- 4. 1. Scope of work with material and maintenance:

A. MAINTENANCE OF BULL SHEDS

I. WORK TO BE DONE IN BULL SHEDS ON DAILY BASIS

- a) Cleaning of floor(s) twice daily, walls, roof, ceiling roof, open area, verandah area, corridors, loafing area, Bull shed corridor, Semen collection area, mangers and water troughs twice daily, white washing of water troughs every week.
- b) Bathing of bulls should be done twice daily throughout the year.
- c) Clean and optimum amount of water shall be made available 24 hours to the bulls for drinking.
- d) Picking, collection and disposal of Bull dung to the designated spot twice daily (Compost Pit Spot)

II. Material and Maintenance required for the work to be performed at Semen Bank, HLDB, Gurugram.

- 1. Brooms with bamboo sticks
- 2. Brooms
- 3. Tasla
- 4. Belcha
- 5. Plastic Water Pipe of sufficient length
- 6. Broom ring
- 7. Khat- fawda
- 8. Plastic scrubbing Brushes

Note:- There are 39 bulls shed with approximate total area of sheds 3260 Sq. Yard.

III. WORK TO BE DONE TWICE IN A DAY (MORNING & EVENING)

- a) Picking, collection and cleaning of Bull dung, leftover green & dry fodder from troughs and Sheds.
- b) Bathing of Bulls.
- c) Feeding & Watering of Bulls.
- d) Cleaning of Semen Bank Premises like lobby of bull sheds, collection area, surrounding area front and back of bull sheds. Premises surrounding the lab.

B. CULTIVATION AND FEEDING OF GREEN/DRY FODDER

I. WORK TO BE DONE ON DAILY BASIS

a) Green fodder shall be grown in the available field(s)/farm land of Semen Bank Gurugram as per season & instructions of the HLDB Officials by the successful bidder.

- b) Green fodder shall be harvested on daily basis in optimum quantity as per instructions of the HLDB Officials.
- c) After harvesting and chaffing, the quantum of green fodder shall be weighed on a digital weighing scale under the supervision of the official/officer of Semen Bank Gurugram. (Digital weighing scale and weighing bags will be provided by the bidder and scale should be got calibrated regularly from approved sources)
- d) Dung Manure from compost pit, as per availability and requirement, will be put/spread & mixed by ploughing in the vacant fields before sowing next cycle of crop by the contractor.
- e) After harvesting, chaffing &weighing the green fodder & dry fodder (Wheat Bhusa) shall be made available to the bulls in their respective shed.

I. Material required for Cultivation of fodder in field

- 1. Darati
- 2. Kassi
- 3. Plastic Khal
- 4. Tube wells and sewage disposal motors will be maintained & repaired if required by the bidder /contractor.(If any repair is required it will be carried out by the bidder /contractor, meanwhile alternate arrangement will also be done by bidder /contractor and no bills can be raised for the payment of the same as the tube well and disposal motor will be handed over in good working condition)
- 5. Jhota Buggi (Bull Cart) will be maintained & repaired if required by the contractor.(IF the bull is available with semen back otherwise the bidder/contractor will do all necessary arrangement in this respect. No other animal of the bidder/contractor will be allowed in the premises of the Semen Bank Gurugram)
- 6. Electric Chaff Cutter with Motor and its alignment will be maintained & repaired if required by the bidder/contractor & all its accessories (i.e.) Motor, Patta/Belt, Blade, File, Oil etc will be arranged by the contractor (all safety measures while performing the will be taken by the bidder/contractor. Any mishap will be the sole responsibility of the bidder/contractor.)

Note:- Total Area of land is approximate 12 Acre, 7 Kanal, 6 Marla and total area of cultivated land is Approximate 8 Acre.

II. OTHER RELATED WORKS TO BE DONE BY CONTRACTOR

- a) 3 successful cycles of crops shall be grown every year by the bidder & before each new agricultural cycle the field/land shall be cultivated 4 times (Twice by harrow & Twice by Tractor & Cultivator), sowing of the seeds will be done by sowing machine only. Computerized Field levelling will be done by the contractor, whenever required, under the supervision of the official/officer Semen Bank Gurugram.
- b) The land shall be irrigated before and after the seeding procedure as per the requirement.
- c) Seeds for seeding shall be made available by the HLDB/Department.
- (d) Tube wells will be maintained & repaired if required by the bidder /contractor. (If any repair is required, it will be carried out by the bidder /contractor, meanwhile alternate arrangement will also be done by bidder /contractor and no bills can be raised for payment of the same to Semen Bank Officer Gurugram as the tube well and disposal motor will be handed over in good working condition)

- (e) Maintenance and repair of all the pipe lines required for water supply in bull sheds, parks, office, Labs. Balls, Valves in over head tanks, Valves and Taps in Bull Sheds and Semen Bank Premises.
- f) Maintenance, repair or replacement of all the main hole covers of the sewages and Bull shed will be done by the contractor. No bills can be raised for payment of the same to Semen Bank Officer Gurugram.

C. MAINTENANCE OF LANDSCAPING WORK IN THE PARKS AND SEWAGE MAINTENANCE

a) The parks situated in the north and south side of the laboratory, and the park situated behind the bull shed southern area of the premises and the park situated near tube well No.1 shall be a maintained with greenery and flowery plants and shrubs and grass of the parks shall be cut on time using grass cutter machine and under supervision of the official/officer Semen Bank Gurugram

Note:- Areas of the parks etc. to be landscaped is approximately 3280 Sq. Yard.

- 1. Material required for Park maintenance
 - a. Talwar for grass cutting and mechanized grass cutting machine
 - b. Plastic water pipes
- 2. Material required for sewage maintenance

D. Specific Terms and Conditions/Eligibility Criteria related to the above Work Eligibility Criteria:-

- 1. The contractor/Bidder enlisted on the date of submission of e tender minimum upto Rs.50.00 lakhs with any Govt. Department of Haryana i.e. PWD B&R, PWD Irrigation Department, Horticulture Boards/Corporations of Haryana State Govt./ Central Govt are eligible to participate in tender without getting themselves registered with Haryana Livestock Development Board.
- 2. The Bidder should have submitted the Documentary Proof for similar nature of work to State Govt./ Central Govt./ Autonomous bodies/ PSU institutions during proceeding three financial years (i.e. current year and three previous financial years) as on opening of bid, as per following criteria:-
 - 1. Single order of at least 30 lac or
 - 2. Two orders of at least 20 lacs each or
 - 3. Three orders of at least 10 lac each
- 3. The Average Annual Turnover of the bidder shall not be less than 30 lacs during the last three financial years i.e. 2019-20,2020-21 and 2021-22(Annexure R-I).

- 4. An affidavit on judicial stamp paper of Rs. 10/- as per **Annexure-R** duly attested by Notary regarding non conviction and not debarred/ blacklisted of firm/bidders by any State Govt. or Union Govt. for the said item.
- 5. The Bidder shall furnish ownership Proofs of Tools & Machinery such as Tractor, Lawn Mower, Shrub Master, Cultivator, Harrow, Khurpi(s), Talwar (s), Kassi, Darati, Tasla, Phatta, Shutli, Phawra etc.
- 6. The Bidder shall have E.P.F, E.S.I, Service Tax & GST registrations and shall furnish the proof and latest challan(s) of the same
- 7. The rates quoted by the bidder shall be inclusive of EPF and ESI

Time Limit:- One year from the date of placement of order (extendable for another one year on same terms and conditions with mutual consent)

TERMS AND CONDITIONS

- 1. TDS shall be deducted from each bill as applicable (1% from individuals/ Proprietorship firms, 2% from Others) if any as per Govt. instructions issued.
- 2. The Average Annual Turnover of the bidder shall not be less than 30 lacs during the last three financial years i.e. 2019-20, 2020-21 and 2021-22 (Annexure R-I).
- 3. The work can be increased and decreased as per requirement.
- 4. In case if any work(s) is not performed satisfactorily then the Managing Director, HLDB holds the right to carry out such work(s) on expenses against the Earnest money/ Performance Security deposited by the bidder.
- 5. If the work is stopped for 1(One) day penalty of Rs. 5000/- and if the work is stopped for second consecutive day, then the penalty of Rs. 10,000/- will be imposed to the firm.
- 6. It is in absolute Authority of Managing Director, HLDB to verify eligibility and originality of any documents submitted by the bidder.
- 7. The Managing Director, HLDB holds the right to cancel any or all bids without assigning any reason whatsoever.
- 8. It is mandatory that the contractor workers will be tested bi-annually against infectious, contagious diseases as per the Minimum Standard Protocol of Semen Bank, Gurugram. The cost will be borne by the contractor. Further, all the workers should have been vaccinated with two doses of Covid Vaccine.
- 9. Safety and security of the Contractor Labour is wholesome responsibility of the contractor. Any injuries, accidents, causality to the contractor labour occurred at/ in Semen Bank, Gurugram premises/during the work of Semen Bank, HLDB, Gurugram will be wholesome liability and responsibility of the contractor. Semen Bank Officers / Vety. Surgeons / Staff / HLDB Board / Department will not be responsible or liable in any manner.
- 10. Any damage to the Govt. property / implement the rules by the contractor's labour will be the liability of the contractor to replace or rectify the damage property or compensate the loss whichever shall be decided by the competent authority.

- 11. In case of dispute appeal can be made to the Arbitrator i.e. Managing Director, Haryana Livestock Development Board, Panchkula. The decision of the Arbitrator shall be final and both parties are bound to accept it.
- 12. All kind of provisions & Rules under wages, labour laws and Acts shall be followed and complied with strictly by contractor. Contractor shall also be sole responsible to maintain required record/register under said laws and acts. The contractor must have valid labour license issued by labour department Haryana.
- 13. The contractor have to submit the declaration on non-judicial stamp paper that all the documents uploaded by me/us are true and correct & at any stage if any documents are found false/fabricated then I/we will be fully responsible for the same and the concerned authority shall have the right to cancel my/our contract agreement.
- 14. The contractor shall be blacklisted for one or two years, if his conduct during the work is found unsatisfactory and/or otherwise document submitted by him are found spurious/fake at any stage during the period of contract or after.

 - 1. Procurement of Stores through e-tender System:-

Where ever Haryana Livestock Development Board considers expedient that more than one supplier / manufacturers should be kept on rate contract, it may so decide on case to case basis.

2. EMD:-

The firms are required to deposit Earnest Money as indicated above failing which the tenders are liable to be rejected. Manufacturing Micro & Small Enterprises (MSEs) of the State, Central or Haryana Public Sector Enterprises and "approved sources" as declared by the Industries Department, Haryana, are exempt from the deposit of EMD.

3. Performance Security:

The successful tenderer shall be required to deposit Performance Security Deposit as per provisions contained in Govt. of Haryana G.O. No. 2/2/2016-4I BII(2) dated 20-10-2016 as under:-

#Haryana based MSEs will be eligible for performance security deposit @ 0.2% who have filed SSI Certificate/EM Part-II/Udyog Aadhaar Memorandum (UAM)/Udyam Registration in Haryana and who participate directly in the tendered/quoted items and offering to supply the entire work/supply order by their enterprise.

The performance security in excess of the EMD already deposited shall be submitted in the shape of Demand Draft/Banker's Cheque in favour of Semen Bank Officer, Gurugram.

4. Price Fall Clause:

The price quoted in the tender/quotation or approved in the Rate Contract for the stores shall not exceed in any way the lowest price at which the tenderer quote for the supply the stores of identical description to DGS&D, New Delhi/ State Government Institutions/ Undertakings /any other person during the delivery period/currency period of the rate contract. If, at any time during the delivery period/currency period, the successful tenderer reduces the rates/sale price of the quoted stores to any person at the price lower than the price chargeable under the supply order/ rate contract, the tenderers should forthwith notify such reduction and inform this office and the price payable under the supply order/contract for the stores supplied after the date of coming into force of such reduction of the rates shall stand correspondingly reduced to that level. The successful tenderers shall promptly notify the reduction of rates to this office as well as to the concerned Indenting Officer/ Consignees. The tenderer shall also give a certificate on their bills that the rates charged by them are not in any way higher to those quoted by them to the DGS&D, New Delhi and other State Government etc., during the corresponding period. The Indenting Officer shall be required to ensure that requisite certificate is given by the concerned firm on the bills before releasing their payments.

5. The bidders are required to quote the basic rates, the delivery/ transportation costs/ applicable GST and duties etc, and the place of billing for the supply of stores clearly and separately. The bidders are required to intimate the place of billing.

6. Negotiation of Rates

Regarding negotiations of rates, policy issued by the State Government vide G.O. No.2/2/2010-4-IB-II dated 18.06.2013, G.O. No.2/2/2010-4-IB-II dated 16.06.2014 G.O. No.2/2/2010-4-IB-II dated 09.02.2015will be applicable.

7. Concession to MSMEs of State:

The State Government has notified "Haryana State Public Procurement Policy for MSME -2016" vide G.O. No. 2/2/2016-4I BII(1) dated 20-10-2016 and amendment vide G.O. No. 2/3/2018-4IB-II dated 23.04.2018 which will be applicable in respect of concessions to Haryana based MSMEs and KVIs. 8. Concession/benefits to Startups/First Generation Entrepreneurs of State:

The State Government has notified "Concession/benefits in Public Procurement to Startups/First Generation Entrepreneurs of State" issued vide G.O. No. 2/2/2016-4I B-II dated 03.01.2019 which will be applicable in respect of concessions to Startups/First Generation Entrepreneurs of State. For claiming the relevant concession/s like Tender Fee, Earnest Money Deposit (EMD), Turnover, Exemption in respect of Past Performance & Experience, Purchase Preference and Performance Security, the bidders are required to submit the documentary proof as per the said policy.

9. In case of evidence of cartel formation by the bidder(s), the EMD is liable to be forfeited along with other actions as are permissible to Government like filing complaints with the Competition Commission of India and/ or other appropriate forums.

10. Purchase Preferences for approved Sources

The Haryana Livestock Development Board, reserves the right to allow purchase preference to the approved sources, including Central or Haryana State Public Sector Undertakings/Enterprises, provided that such approved source takes part in the bidding process and the quoted prices of the approved source is within 10% of the lowest acceptable price, other things being equal. However, such purchase preference would be available to the approved source only at the lowest acceptable price. The latest list of Approved Source is contained in Government Order no. 6/03/2007-4IB-II dated: 14-02-2008 of the Industries Department and is subject to further amendment from time to time

11. Grievance Redressal Mechanism for dealing with the representations/ complaints/ letters of the participating bidders/ firms:

A time bound Grievance Redressal Mechanism for dealing with the representations/ complaints/ letters of the participating bidders/ firms in the tendering process in the State Public Procurement will be governed by State Government Policy issued vide G.O No.2/2/2016-4I-B II of dated 25.07.2016 All the bidders/ firms who want to make any representation/ complaint against any issue related to their technical scrutiny of the bids may do the same within 5 working days (up to 05:00 P.M. of the Fifth Working day) of the date of issue of letter/ intimation regarding their **As per NIT/ Not as per NIT status.** They have to ensure that their communication is delivered/ reached within 5 working days and delay in postal will not be counted as a valid reason. No representation/ complaint in whatsoever manner from the bidders/ firms will be entertained after the opening of Financial Bid.

12. Arbitration Clause

- (d) That, if at any time, during the operation of this agreement or thereafter the Board is made liable in any manner whatsoever by any order, direction or otherwise of any Court authority or tribunal, to pay any amounts whatsoever in respect of or to any of present or ex-personnel of the SERVICE PROVIDER/FIRM/AGENCY or to any third party in any event not restricted but including as mentioned in sub-clauses No (a), (b) and (c) hereinabove, the

The department shall be entitled to deduct any such amounts as aforesaid, from the security deposit and/or from any pending bills of the SERVICE PROVIDER/FIRM/AGENCY.

10. LIABILITIES AND REMEDIES

13. TERMINATION

- (a) Either party can terminate this agreement by giving one month's written notice to the other without assigning any reason and without payment of any compensation thereof. however, the department shall give only a 24 hours notice of termination of this agreement to the SERVICE PROVIDER/FIRM/AGENCY when there is a major default in compliance of the terms and conditions of this agreement or the SERVICE PROVIDER/FIRM/AGENCY has failed to comply with its statutory obligations.

Further, the failure of the department to enforce at any time, any of the provisions of this agreement or to exercise any option which is herein provided for requiring at any time the performance by the Service Provider of any of the provisions hereof shall in no way be construed to be a waiver of such provisions of this agreement nor in any way affect the validity of this agreement or any part thereof or the right of the department to enforce the same in part or in the entirety of it. Waiver, if any, has to be in writing.

23. FORCE MAJEURE

Neither party shall be in default if a failure to perform any obligation hereunder is caused solely by supervening conditions beyond that party's reasonable control. including acts of God, civil commotion strikes, acts of terrarium labour disputes and governmental or public authority's demands or requirements.

24. **DISPUTE RESOLUTION**

This agreement shall be deemed to have been made / executed at ______ for all purposes in the event of any dispute related to the interpretation or rights or liabilities arising out of this agreement the same shallat first instance, be amicably settled between the parties. If any dispute is not settled amicably, the same shall he referred to the sole arbitrator to be appointed by the department. The award given by the arbitrator shall be final and binding on the partied. The venue of arbitrator shall be at Panchkula.

25. GOVERNING LAW/JURISDICTION

The applicable law governing this agreement shall be the laws of India and the courts of Panchkula shall have the exclusive jurisdiction to try any dispute with respect to this agreement.

26. TWO COUNTERPARTS.

This agreement is made in duplicate. The Service Provider shall return a copy of this agreement duly signed and stamped as a token of acceptance of all terms and conditions mentioned above. In the event of commencement of order acceptance, it will be taken that all terms are acceptable.

27. SECURITY

The service provider shall deposit a security of 3% on the execution of this agreement. If the Board suffers any loss on account of fraud, negligence or dishonesty of the manpower engaged by the service providers in the discharging of his duties, the department shall be entitled to recoup such loss out of the security deposits. The security of the service providers shall be returned to him after the three months after the termination of the agreement if the department has no claim against him.
